## Overview

TGP Capital Partners is a Kansas City based private equity firm that makes both control and minority equity investments in well-managed, profitable, and growing companies in basic industries including the manufacturing, distribution, business services sectors. We seek opportunities to partner with proven managers in support of their strategic growth plans. Specifically, we provide equity capital for:

- **Growth strategies** – either acquisitions or internal initiatives
- **Recapitalizations** of the existing capital structure
- **Full or partial liquidity** for existing shareholders
- **Management buyouts**

## Investment criteria

TGP seeks opportunities to sponsor proven leaders in their respective industries. Additional parameters include the following:

- **Company size:** Revenues between \$15mm and \$100mm; EBITDA in excess of \$2mm
- **Industry:** Preference for Manufacturing and Business Services sectors; addressable markets of at least \$300mm. Will not consider financial institutions, real estate, retail, or start-ups
- **Geography:** No restriction – focus on greater Midwestern U.S.
- **Control:** Majority control or minority investment structures
- **Investment size:** Up to approximately \$10mm from the Fund. Considerably larger with co-investment partner

## What differentiates us

- **Experience and Reputation:** TGP's partners have been collectively involved in private equity investing for more than three decades. Current and former portfolio company executives are our best references.
- **Flexibility:** We make minority or majority equity investments and are open to creative transaction structures, all with the sole "win-win" focus of *creating wealth for shareholders and management*.
